1. For the first year of service, salaried employees will receive ONE day of vacation for each month of service, and hourly employees will receive ONE-HALF day of vacation for each month of employment, but that no vacation may be taken during the first six months probationary period.
2. Employees with ONE to TEN years (inclusive) of service shall receive TWELVE days' vacation per year.
3. Employees with ELEVEN to NINETEEN years (inclusive) of service shall receive EIGHTEEN days' vacation per year.
4. Employees having completed TWENTY years or more service shall receive TWENTY-FOUR days' vacation per year.
5. Employees may carry over FIVE days of vacation into the next fiscal year.
6. The Village Clerk, Village Treasurer and Public Works Superintendent will govern their vacation days with discretionary approval of the Mayor. All other employees shall make written application to these department heads so that vacation schedules may be planned in advance. In the event of conflicts in requests for vacation days, department heads will make their decisions on the basis of seniority.
7. Upon formal resignation, retirement or death of an employee, any unused vacation accumulations and salary due shall be paid at the then current rate to the employee or beneficiary.

And Whereas: Our rescue squad performs a service first and foremost for the residents of the Village of Mayville and the Mayville Protection District.

And Whereas: The Mayville Rescue Squad shall from time to time be called to assist neighboring departments with mutual Aid.

And Whereas: The Mayville Rescue Squad has certain pieces of equipment used on rescue calls.

And Whereas: Some pieces of equipment are duplicated in both the ambulance and the fly car.

And Whereas: When the alarm sounds for a mutual aid call and the fly car is requested to assist a neighboring department, the residents of this village and our contracted protection district should not be compromised by the mutual aid call.

And Whereas: The Mayville Rescue Squad has 2 Life Pac heart defibrillation units, Life Pac 12 and a Life Pac 15.

And Whereas: The Life Pac 15 is assigned to the ambulance.

And Whereas: The Life Pac 12 is assigned to the mutual aid fly car.

And Whereas: The fly car has been designated as the response vehicle used for mutual aid rescue calls where ALS is requested.

Now therefore be it resolved: That at no time shall the Life Pac 15 be removed from the ambulance and taken in concert with the Life Pac 12 on a mutual aid call.

And Be it Finally Resolved: Willful failure to maintain a sufficient level of equipment within the district for response to calls for our residents will result in an inability of our rescue squad members to perform rescue measures as may be required for our residents within the boundaries of the Mayville Rescue territory thus leaving us unable to perform lifesaving treatment that may require the use of the Life Pac 15.
