Meeting called to order at 7:00 p.m.

Pledge to the flag.

Drew Rodgers, Pat Gooch, and Don McCord reviewed the plan for the Rails to Trails resurfacing Project that will be taking place through Lakeside Park it is estimated that it will begin sometime in August of 2016. Don McCord presented the board with some drawings and suggestions of possible beautification plans for the parking area located by the depot as well as a suggestion that possibly more of the decorative lights currently used in the village be added and placed further down the street to connect the trail to the upper village. Trustee Syper expressed his concern for the village having to absorb the cost of the maintenance of the trail years down the road.

Members of the board want to ensure that the enhanced patrols are not just setting up radar and writing traffic tickets, but would rather that the officers concentrate on patrolling the neighborhoods and interacting with the village residents. Mayor Bova stated that he would write a letter and formal written request for a memorandum of understanding as to the intentions of the board for the enhanced patrols in the village and the

absence of such a document would possibly result in the board not passing the resolution to sign the agreement to fund the patrol.
