It was also stated that the building would be available for any organization to use when repairs are completed.

Mr. Buxton also explained the repairs that will be done to the waterline located on Academy street.

Mayor Bova explained why a tree had been cut down over the weekend at Lakeside Park that had split and become a hazard to the visitors to the park.

Hank Grosel expressed his concerns with the derelict property locate at 199 Sea Lion Drive and the fact that nothing has been done with it for the last ten years and the fact that the Village has done nothing to remedy the situation but however continue to collect the tax money from all the residents in the immediate area of that property with no resolve to the issue. Mr. Grosel stated that there are now rats in the area that have never been in that area before and garbage is being dumped periodically on the property as well.

Mayor Bova stated that the Village was in fact pursuing the issue through its legal council and hoped to have some resolve to the issue in the near future.
